**Explanation of Responses:**

- Reflects the vesting of RSUs.
- Each RSU represents a contingent right to receive one share of the issuer's Common Stock upon settlement.
- The RSUs will vest in four equal installments on each August 25, November 25, February 25 and May 25 following the grant date and, if not fully vested, shall vest in full on the earlier of (i) the date of the 2025 annual meeting of the Company's stockholders or (ii) June 12, 2025 subject to the reporting person's provision of service to the issuer on each vesting date.
- The RSUs were granted with both (a) a liquidity event-based vesting condition and (b) a service-based vesting condition, both of which must be satisfied in order for the RSUs to vest. The liquidity event-based vesting event was satisfied on September 22, 2021, the effective date of the issuer's initial public offering. The service-based vesting event will be satisfied as to 1/4th of the total shares underlying the RSUs on November 25, 2021 and then 1/16th of the total number of shares vest quarterly on each February 25, May 25, August 25 and November 25 thereafter, with 100% of the total shares underlying the RSUs vested on November 25, 2024, subject to the reporting person's provision of service to the issuer on each vesting date.
